ORDER

Based on the orders of the Hon'ble National Green Tribunal (NGT) in O.A No. 673/2018, pertaining to action plan for the 21 critically polluted river stretches in Kerala, it has been decided to prepare a plan to prevent the pollution in rivers and to restore its pristine quality through a holistic approach where the Water Resources Department and the Engineering Colleges could work together for developing new and innovative solutions for the abatement of pollution in the 21 critically polluted rivers in the State.

2. Government, as per the order read above accorded sanction to the participating Engineering Colleges to carry out all works relating to the preparation of actionable DPRs for abatement of pollution in the 21 critically polluted rivers in the State.

3. It has come to the notice of Government that the participating Engineering Colleges have started the DPR preparation and have collected samples from the polluted river stretches and that the Managing Director, Kerala Water Authority as per his note read 4th paper above directed the labs of Kerala Water Authority and that of Ground Water Department to collect samples for water quality testing from the participating Engineering Colleges.

4. Government, after having examined the matter in detail are pleased to order that all participating Engineering Colleges as per Annexure-I , enclosed herewith are permitted to avail the lab facilities of Kerala Water Authority, Ground Water Department & Irrigation Department for carrying out the water quality testing in the 21 critically polluted rivers of the State.

5. The Managing Director, Kerala Water Authority and the Chief Engineer, Irrigation and Administration shall ensure that the samples are collected at their respective labs and that all the parameters are tested and the results given to the participating Engineering Colleges, concerned expeditiously.

Annexure - II

Operational Guidelines

- 1) Colleges are permitted to submit their samples to their nearest QC lab of either KWA/GWD. Thereafter colleges may intimate by email IDR/KBWA the details of sample submitted such as;
 - i. River from which the sample is collected,
 - ii. Unique code to the sample collected (preferably alphanumeric - 8 characters)
 - iii. Geographic location of sample taken.(latitude, longitude)
 - iv. Time of sample collection
 - v. Date of submission of sample to QC lab.
 - vi. QC lab to which sample submitted
- 2) Respective QC labs may raise bills against the samples tested in the names of the respective colleges who submitted the sample. The bills shall clearly mention the unique code of the collected sample.
- 3) Test results shall be sent by the respective QC labs to the email id of IDR/KBWA, who shall upload the results in public domain.
- 4) QC labs shall give topmost priority to testing of the samples collected under this programme.
- 5) Under no circumstance shall a test result be delayed beyond 5 days.
- 6) Colleges shall intimate the office of the MD, KWA in case a result is delayed by more than 6 days.(mdunitkwa@gmail.com)
- 7) No QC lab shall reject a sample delivered to them citing lack of testing capabilities. It shall be the duty of the lab to take the sample to the nearest QC lab having such facility.
